**WHEREAS**, sealed bids were received by St. Charles Parish on November 27, 2018, for the Oak Street Improvements project; and,

**WHEREAS**, Evans-Graves Engineers, Inc., Stephen Lundgren, P.E., the Consulting Engineer for the Project, has reviewed the bids and recommended that the Contract be awarded to the lowest responsive bidder, Sealevel Construction, Inc., in the amount of \$1,062,870.00.
