Use Regulations, a., by adding (13) Lawn Section VII. Service. and amending Supplemental use Care performance regulations, 1. by adding Lawn Care Service. THE ST. CHARLES PARISH COUNCIL HEREBY ORDAINS: **SECTION I.** That the Code of Ordinances, Appendix A, Section III. Definitions be hereby amended with new text underlined and deleted text in strikethrough: Lawn Care Service: A business offering gardening and lawn maintenance activities, such as mowing lawn and overgrowth, edging, weeding, or trimming of hedges and shrubberv. SECTION II. That the Code of Ordinances, Appendix A, Section VI. Zoning district criteria and regulations A., [I.], 1. a. is hereby amended with new text underlined and deleted text in strikethrough: (13) Lawn Care Service subject to the requirements of Section VII. SECTION III. That the Code of Ordinances, Appendix A, Section VII. Supplemental use and performance regulations, 1. is hereby amended with new text underlined and deleted text in strikethrough to be added after Junkyards: Lawn Care Service. a. No onsite signage allowed other than signage on vehicles and equipment when operating in the O-L zoning district.
